Release of Liability and Assumption of Risk Waiver

Conditions:

In consideration for being allowed to participate in any way in the Surf City Parks & Recreation Department programs, athletics, camps, and/or related events and activities, the undersigned: Hereby expressly represent that I/my child is free from any physical illness, condition, limitation, or that which cannot be reasonably accommodated in accordance with the American with Disabilities Act, which may prevent or hinder myself/my child from taking an active and safe part in the activity being offered by the Surf City Parks & Recreation Department. Understands that I/my child is not to participate in the program when I/he/she has an illness, injury, physical or mental limitation which would endanger my/his/her safety or the health of others. Acknowledge and fully understand that each participant may be engaging in activities that involve risk of personal injury, including permanent disability or death, and social and economic losses which might result not only from their own actions, inactions or negligence but the actions, inactions or negligence of others, or from conditions of the premises or equipment used. Further, there may be risks not known to us or not reasonably foreseeable at this time. Assumes all the foregoing risks and accepts personal responsibility for the damages of self and equipment following such injury, disability or death.

Participant's Agreement:

Do hereby agree to participate in all activities during the current season, or for specified duration of the activity and further agree to carefully observe and faithfully abide by the rules and regulations set up for this activity by the Surf City Parks & Recreation. I/my child will conduct themselves in a manner which conveys comradeship, sportsmanship and civility towards others. All participants will respect the rights of others and will conduct themselves in a manner which does not detract from the enjoyment of participation by others. Failure to comply with this agreement may result in administrative action by the Parks & Recreation Department and may include the loss of participation privileges. Agrees to abide by all rules and regulations of the Surf City Parks & Recreation Department, the facilities, town and public sites, parks, affiliated clubs, agents, owners and leasers of premises used by the Department. Further, agrees to report persons not abiding by those rules to the Supervisor on duty. Agrees prior to participating, each participant will inspect the facilities, site, and equipment to be used. If they believe it to be unsafe, they will advise the supervisor on duty of such conditions and refuse to participate.

Medical Authorization:

Do hereby give the Surf City Parks & Recreation Department permission to have myself/ child transported to the nearest medical facility and/or be seen by a physician if it is deemed necessary during my/his/her participation in the activity.

Waiver:

I, as the below named participant, or I, the undersigned as parent or guardian of the below named participant, do hereby release the instructor, supervisor, their staff, sponsors, and representatives, of all activities and of all responsibility or liability of any nature whatsoever for any injury or aggravation of a pre-existing condition, for any bodily injury resulting from the normal risks of the activity, including group travel.

Release, waive, discharge and covenant not to sue the Surf City Parks & Recreation Department, the Town of Surf City, affiliated clubs, respective administrators, directors, coaches, employees of the town or organizations, volunteers, participants, sponsors, advertisers, and if applicable, owners and leasers of premises used to conduct the event, all of which are here and here after referred to as "releases" from any and all liability to each including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releases or otherwise.

Give permission for the participant to leave the Surf City Community Center grounds with authorized Surf City Parks & Recreation Department staff for scheduled trips and outings.

Photo Release:

I give permission for my/my child's photo and/or name to be used in any media publications, including but not limited to local newspapers and the Town of Surf City's website or social media.
